Section 226 (1) (a) of the Town and Country Planning Act 1990

The Acquisition of Land Act 1981

Birmingham City Council (in this order called "the acquiring authority") makes the following order –

1. Subject to the provisions of this order, the acquiring authority is under section 226 (1)(a) of the Town and Country Planning Act 1990 hereby authorised to purchase compulsorily the land described in paragraph 2 below for the purpose of carrying out development redevelopment and improvement thereof by the demolition of buildings and new construction for general industrial, manufacturing, warehouse and distribution purposes (Use Classes B2 and B8) together with the construction of vehicle access, associated car parking and landscaping and other associated works to contribute to the promotion and improvement of the economic, social and environmental well-being of the acquiring authority's area.
2. The land authorised to be purchased compulsorily under this order is the land described in the Schedule below and delineated and shown hatched black on the map, which has been prepared in duplicate, sealed with the common seal of the acquiring authority and marked: "Map referred to in The Birmingham City Council (Brickfield Road Tyseley) Compulsory Purchase Order 2019."
