The Community Infrastructure Levy Draft Charging Schedule sets out proposed charges for development in Birmingham to help support infrastructure provision.

Birmingham City Council submitted its CIL Draft Charging Schedule to the Planning Inspectorate on Wednesday 4 February 2015 for public examination in accordance with Section 212 of the Planning Act 2008 (as amended) and Regulation 19 of the Community Infrastructure Regulations 2010 (as amended).

The Draft Charging Schedule is now subject to independent examination.

Any person may request to be heard by the Examiner in relation to the modifications. Requests to be heard must include details of the modifications on which the person wishes to be heard (by reference to the Statement of Modifications). Additional detail is sought in relation to whether those requesting to be heard support or oppose the modifications and why. The Council will submit a copy of each request it receives to the Examiner. Requests to be heard may be withdrawn

at any time by giving notice in writing to the Council. Please note that representations received cannot be treated as confidential.
