We have recently been made aware of a washroom services provider who is automatically rolling customers onto a 3 or 5 year contract. In some cases a 90 day termination period must be served.

Don't get caught out - We highly recommend you contact your current provider to ascertain and clarify the contract end dates for each piece of equipment listed for your school. Please check your records now and diarise when you need to give notice or you may be stuck in an out dated contract that you cannot escape for up to 5 years.

Automatic Meter Reading (AMR) roll-out

What's happening?

Total Gas & Power are currently undergoing the installation of AMR meters for all sites. If you have not already had a meter exchanged, one of the below contractors will be in contact to arrange the meter exchange.
