Acocks Green ward is located in the south east of the city. It has a population of 24,490 making it the 7th most populous ward in the city.

The ward has a similar age profile to the city as a whole and a similar ethnic make-up.

Acocks Green is mid ranking amongst the city's 69 wards for deprivation levels.

Resident employment rates in the ward are above the city average and claimant count unemployment proportions are in line with the the Birmingham average.





Child Poverty

Department for Work and Pensions (DWP) data on the number and proportion of children living in low income families provide an indication of the number of children living in poverty in each ward of the city. Low income families are defined as those whose household income is less than 60% of average household income. Only families who have claimed Child Benefit and at least one other household benefit are included in the statistics.

In 2021/22 there were 2,724 children living in low income households in Acocks Green, 38.4% of all children in the ward, meaning the ward is ranked 26th in the city in terms of the levels of child poverty.

Economic Output

New experimental data from the ONS provides Gross Value Added (GVA) a measure of economic output at LSOA level. Ward economic output has been calculated using an LSOA best fit approach. Total economic output in Acocks Green stood at £268m in 2020 (latest data available) and GVA per head was £11,268. Acocks Green has the 23rd largest ward economy in the city in terms of GVA.
