Gravelly Hill Ward Factsheet



Gravelly Hill is an inner city ward located in the north of the city. It has a population of 10,501 making it the 60th most populous ward in the city.

The ward has a similar age profile to the city as a whole and a slightly higher BAME population share.

Gravelly Hill is one of the more deprived wards in the city and has the 21st highest share of working age residents with no qualification levels amongst the city's 69 wards.

Resident employment rates in the ward are below the city average and claimant count unemployment proportions are above the Birmingham average.





Child Poverty

Department for Work and Pensions (DWP) data on the number and proportion of children living in low income families provide an indication of the number of children living in poverty in each ward of the city. Low income families are defined as those whose household income is less than 60% of average household income. Only families who have claimed Child Benefit and at least one other household benefit are included in the statistics.

In 2021/22 there were 3,600 children living in low income households in Gravelly Hill, 44.9% of all children in the ward, meaning the ward is ranked 20^{th} in the city in terms of the levels of child poverty.

Economic Output

New experimental data from the ONS provides Gross Value Added (GVA) a measure of economic output at LSOA level. Ward economic output has been calculated using an LSOA best fit approach. Total economic output in Gravelly Hill stood at £236m in 2020 (latest data available) and GVA per head was £9,741. Gravelly Hill has the 26th largest ward economy in the city in terms of GVA.
