North Edgbaston Ward Factsheet



North Edgbaston Ward is located in the west of the city. It has a population of 22,564 making it the 13^{th} most populous ward in the city.

The ward has a younger age profile than the city as a whole and a smaller BAME share of the population.

North Edgbaston is mid ranking amongst the city's 69 wards for deprivation levels and qualification rates.

Resident employment rates in the ward are just below the city average and claimant count unemployment proportions are above the Birmingham average.





Child Poverty

Department for Work and Pensions (DWP) data on the number and proportion of children living in low income families provide an indication of the number of children living in poverty in each ward of the city. Low income families are defined as those whose household income is less than 60% of average household income. Only families who have claimed Child Benefit and at least one other household benefit are included in the statistics.

In 2021/22 there were 2,334 children living in low income households in North Edgbaston, 41.4% of all children in the ward, meaning the ward is ranked 21st in the city in terms of the levels of child poverty.



Economic Output

New experimental data from the ONS provides Gross Value Added (GVA) a measure of economic output at LSOA level. Ward economic output has been calculated using an LSOA best fit approach. Total economic output in North Edgbaston stood at £317m in 2020 (latest data available) and GVA per head was £12,927. North Edgbaston has the 4th largest ward economy in the city in terms of GVA.
