Stirchley Ward Factsheet



Stirchley is a suburban ward located in the south of the city. It has a population of 10,117 making it the 6th smallest ward in terms of population.

The ward has a broadly similar age profile to the city but has fewer young people and more aged 25-44. The area has a lower BAME population share than the city.

Stirchley is lower ranking amongst the city's 69 wards for deprivation levels.

Resident employment rates in the ward are well above the city average and claimant count unemployment proportions are below the Birmingham average.







Child Poverty

Department for Work and Pensions (DWP) data on the number and proportion of children living in low income families provide an indication of the number of children living in poverty in each ward of the city. Low income families are defined as those whose household income is less than 60% of average household income. Only families who have claimed Child Benefit and at least one other household benefit are included in the statistics.

In 2021/22 there were 656 children living in low income households in Stirchley, 28.2% of all children in the ward, meaning the ward is ranked 47th in the city in terms of the levels of child poverty.

Economic Output

New experimental data from the ONS provides Gross Value Added (GVA) a measure of economic output at LSOA level. Ward economic output has been calculated using an LSOA best fit approach. Total economic output in Stirchley stood at £174m in 2020 (latest data available) and GVA per head was £17,356. Stirchley has the 37th largest ward economy in the city in terms of GVA.
