## Replacement of the Saved Policies of the Birmingham Unitary Development Plan 2005

Paragraph 1.12 of the Pre-submission Birmingham Development Plan (BDP) indicates that on adoption the Plan will replace all the saved policies of the Birmingham Unitary Development Plan (UDP) 2005 with the exception of those contained in Chapter 8. This Schedule expands on that statement by identifying which BDP policy will replace each of the saved policies. There are a number of instances where saved UDP polices are identified as to be abandoned without a specific BDP policy to replace them. In these cases the Council has concluded either that the policy is not necessary or that sufficient guidance is already available in other BDP policies. In due course Chapter 8 of the UDP will be replaced by the Development Management DPD.
