Admissions Policy 2023/2024

Our admissions process is part of the Local Authority co-ordinated scheme. Applicants must apply to Birmingham City Council by the closing date. https://www.birmingham.gov.uk/schooladmissions

The Academy's admission number is **60**.

Children are usually admitted once a year in September, and a meeting for parents of new children is held in the term prior to admission when full details of the everyday routine is given. There is also the opportunity for you and your child to meet the Reception class teacher and see the classroom in which your child will be placed.

More specific information on the curriculum and how you can help your child once he/she is at school is given to you at a meeting held soon after your child is admitted.

Parents and carers are welcome to visit the Academy when they are considering registering their child and arrangements will be made to discuss the work and organisation of the Academy with intending parents. Prior arrangements need to be made for such visits. Please contact the Academy by telephone to make arrangements.

Where the number of applications is lower than the Academy's admission number, all applicants will be admitted. If there are more applications than places available, then all applications received by the Local Authority's designated closing date for receipt of applications will be considered in accordance with the oversubscription criteria outlined below.

Oversubscription criteria

If the number of applications for a particular year group exceeds the number of places available, each application will be given a priority and places will be allocated in the following order:

<u>Priority 1</u>: Children looked after by a Local Authority (in accordance with section 22 of the Children Act 1989) and children who were previously looked after but ceased to be so because they were adopted (or became subject to a child arrangement/residence order or special guardianship order), including those children who appear (to the admission authority) to have been in state care outside of England.

<u>Priority 2:</u> Children with a brother or a sister already at the academy who will still be in attendance in September 2022.

PLEASE NOTE FOR THE PURPOSES OF THIS CONSULTATION THAT THE PROPOSED CHANGE TO THESE PRIORITIES IS THE REMOVAL OF PREVIOUS PRIORITY 3, NAMELY:

<u>Priority 3</u>: Children of parents/carers who regularly worship at a Church of England church in the Deanery of Handsworth. <u>A supplementary information form should be completed for this school if applying on faith grounds</u> and can be requested from the School Office or the Local Authority. We define regular as meaning attendance at church must be at least once a month for a twelve month period prior to application and this will be confirmed by the minister completing the relevant part of the Supplementary Information Form. In the event that during

the period specified for attendance at worship the church has been closed for public worship and has not provided alternative premises for that worship, the requirements of these admissions arrangements in relation to attendance will only apply to the period when the church has been available for public worship.

<u>Priority 4</u>: Other children: proximity of home to school, as measured by a straight line from the child's residential home address to the school front entrance gate. **To be clear: proposed 2023/24 admission criteria is as follows:**

- Children looked after by a Local Authority (in accordance with section 22 of the Children Act 1989) and all children who were previously looked after but ceased to be so because they were adopted (or became subject to a child arrangement/residence order or special guardianship order), including those children who appear (to the admission authority) to have been in state care outside of England.
- 2. Children with a brother or a sister already at the academy who will still be in attendance in September 2022.
- 3. Other children: proximity of home to school, as measured by a straight line from the child's residential home address to the school front entrance gate.

Notes:

- 1. Children with an Education & Health Care Plan that names St Mary's CE Academy, Handsworth will be offered a place. This is not an oversubscription criterion and may reduce the number of places available.
- 2. Under priority 2, a brother or sister must live at the same address and could be:
 - A brother or sister sharing the same parents;
 - A half-brother or sister, where two children share one parent; a stepbrother or stepsister, where two children are related by a parent's marriage or civil partnership (a formal arrangement that gives same-sex couples the same legal status as married couples);
 - The separate children of a couple who live together; or
 - An adopted or fostered brother or sister.
- 3. For the purposes of education law, the Department for Education considers a 'parent' to include:
 - all biological parents, whether they are married or not;
 - any person who, although not a biological parent, has parental responsibility for a child or young person - this could be an adoptive parent, a step-parent, guardian or other relative;
 - any person who, although not a biological parent and not having parental responsibility, has care of a child or young person. A person typically has care of a child or young person if they are the person with whom the child lives, either full or part time and who looks after the child, irrespective of what their biological or legal relationship is with the child.
- 4. The home address is the place where the child is permanently resident with his or her parent(s). If care is shared between two parents, parents will need to provide a copy of the court order defining the arrangement. In the absence of a court order, we will use the address of the parent who is in receipt of the child benefit. Parents will need to send a copy of your child benefit award for the last two years. [In the event of a dispute between two parents who each have parental responsibility, the matter may ultimately need to be resolved by the courts.]

- 5. If offering places within any one of the priorities would cause the Academy's admission number to be exceeded, then children living nearest will be offered first. Distances are measured by the Local Authority. If two or more applicants share the same distance to the Academy and only one place is available, the applicant to whom the place will be offered will be determined by the Local Authority by random selection (unless this involves multiple births, in which case the Academy will consider admitting all the siblings).
- 6. Applications received after the Local Authority's designated closing date for receipt of applications will be deemed to have been made late and will be considered after applications with the same priority that were received on time.
- 7. **Waiting lists** are produced in strict order of priority, against the over-subscription criteria. Waiting lists are kept until the end of the autumn term in the year of admission.
- 8. **In-Year applications**: Parents can apply for a place for their child at any time and for any school or Academy. Applications made outside the normal admissions round for St Mary's C E Primary Academy and Nursery, (in-year admissions) should be made directly to the Academy. On receipt of an in-year application, the Academy will notify the local authority of both the application and its outcome to allow the Local Authority to keep up to date with figures on the availability of school places in their area.
- 9. **Appeals**: Appeals are administered by the Diocese for Fioretti Trust. Information for parents who wish to appeal against the decision to refuse their child admission can be found on our website or contact the school office to request an appeal form. Appeals will be heard by an independent panel.
- 10. **Fair Access Protocol:** The Governing Board recognises its duty to participate in the Local Authority Fair Access Protocol.

11. Nursery Admission:

Follows LA guidelines relating to priority needs and distance from school – full details of the nursery admissions policy is available at the Academy. Attending St Mary's Nursery does not guarantee a place in reception.

12. Admission of children below compulsory school age and deferred entry:

- 12.1 A child is entitled to a full-time place at school in the September following their fourth birthday. The child's parents can defer the date their child is admitted to the Academy until later in the school year, but not beyond the point at which they reach compulsory school age and not beyond the beginning of the final term of the school year for which application was made.
- 12.2 Where parents wish, children may attend part-time until later in the school year but not beyond the point at which they reach compulsory school age.
- 12.3 Compulsory school age is the prescribed day on or following the child's fifth birthday. The prescribed days are **31 December**, **31 March and 31 August**; e.g. For a child born between 01 September and 31 December, their prescribed day will be 31st December and therefore the child must be in compulsory education by the 31st December. For a child born between 01 January and 31 March, the child must be in compulsory education by 31 March. For a child born between 01 April and 31 August, the child must be in compulsory education by the beginning of the final term of the school year (unless the provisions relating to summer-born children below are applied).

13. Admission of children outside their normal age group

- 13.1 Parents may seek a place for a child outside of their normal age group in special circumstances, for instance if the child is gifted and talented or has experienced problems such as ill health. Such applications should be made in writing to the Chair of the Governing Board of the Academy setting out the reasons for the request. A decision will be made on the basis of the circumstances of each case and in the best interests of the child concerned.
- 13.2 <u>Summer-born Children</u> (those born between 01 April and 31 August)
- 13.2.1 Parents of a summer born child may choose not to send their child to school until the September following the child's fifth birthday, when they will apply for the child to enter Year 1. There is no guarantee that a place will be available at *the Academy at* this stage, as the year group may well already be full.
- 13.2.2 Parents of a summer born child may, at the same time as making an application to the LA for Reception in the child's normal age group, make a request of the school's Governing Board that the child may **reapply** to be admitted instead to the Reception Class in the September following the child's 5th birthday. The request should be made in writing to the Chair of the Governing Board of the Academy, setting out the reasons for the request. The Governing Board will make its decision on the basis of the individual circumstances of each case and in the best interests of the child concerned and will set out clearly the reasons for the decision.

If the Governing Board <u>agrees</u> to the parent's request, the existing application for the Reception place may be withdrawn and the parent must then make a **new** application for a place in Reception which will be considered against the normal oversubscription criteria **as part of the main admissions round the following year**, (and there is no guarantee of a place being offered at this Academy at that stage). If the Governing Board does <u>not agree</u> to the parent's request, the parent must decide whether to accept any offer of a place for the normal age group, or to refuse it and make an in-year application for admission to Year 1 for the September following the child's fifth birthday (when, again, there is no guarantee of a place being available at this Academy).

- 13.3 A decision made by one admission authority in respect of admission of a child out of their normal age group is not binding on any other admission authority. Therefore, a child educated out of their normal age group at this Academy may not be accepted out of their normal age group when moving to a different Academy or from primary to secondary school.
- 13.4 Parents' statutory right of appeal against a decision to refuse admission does not apply if the child is offered a place at the school but it is not in the parent's preferred age group.
