2.3 Analysis on Initial Assessment

The proposed centre improvement projects contribute towards the City Councils ultimate aim for residents to Enjoy a High Quality of Life, (Council Business Plan 2011+) by providing local infrastructure improvements which meet the outcome of living, staying safe and clean, green neighbourhoods and succeeding economically, benefitting from education, training, jobs and investment.

An additional benefit will be the development of one part of a heavily contaminated derelict site in the heart of Selly Oak/Edgbaston. This site, known as the Birmingham Battery site, will also accommodate a new retail development by Sainsburys so together the investment will provide significant improvements to the area.

Local people will benefit from the available jobs, local business will benefit in supplying the new companies. There will be collaborative benefits between the Life Sciences Campus, the University of Birmingham research and the Queen Elizabeth Hospital as the Economic Zone develops.

3 Concluding Statement on Full Assessment

The Leader, Deputy Leader, Deputy Chief Executive, Cabinet Member for Development Transport and The Economy have been consulted and support the report proceeding to an executive decision. Selly Oak and Edgbaston Members have been consulted on this report.

The Director of Legal and Democratic Services, Director of Planning and Regeneration, and Quality Assurance and Governance Team have been consulted and are supportive of the report going forward.

There was public consultation carried out in December and January 2013 on the proposals which include the development of a Life Sciences Campus as part of the Sainsbury development at Battery Park, Selly Oak. This included a press release and circulation of leaflets locally.

The development of the Life Sciences Campus proposition has had the benefit of a site valuation from Lambert Smith Hampton and an economic impact assessment and proposition overview from GVA Grimley and was supportive of the development of a Life Sciences Campus.

The acquisition of a remediated site will be compliant with third party requirements for environmental standards. The developed site will be subject to the requirements of planning permission for design, access and use.

The work will comply with all relevant policies and procedures including current planning policy, environmental regulations and practice standards.
