Title: Mainstream Schools 2023/24 Funding Formula Forecast

Status: For Information

Purpose

The purpose of this report is to inform Schools Forum of key National Funding Formula (NFF) changes for 2023/24 and the forecast for Birmingham schools funding allocations in line with the NFF requirements.

Background

Each year local authorities are required to detail their schools block funding formulae in accordance with the arrangements set out by the Secretary of State for Education. The Education and Skills Funding Agency (ESFA) has developed the authority proforma tool (APT) to assist local authorities to model, and then confirm how they plan to do this for the funding year.

Our current modelling and forecasts are based on the APT issued in August 2022 for the 2023/24 schools block funding formulae. The APT is populated with schools' block data primarily drawn from the October 2021 schools census, but with a forecast of pupil numbers for October 2022.

The final version of the APT will be released in December 2022 and must be returned to the ESFA by 20 January 2023. The schools block data in the December version will be updated to use the October 2022 census.

The overall structure of the formula is the same as in 2022/23. Most factors have increased by 1.9%, but with some exceptions.

The council has applied the NFF rates in the APT, with the maximum MFG 0.5% in line with NFF guidance.

Appendix 1 shows a list of NFF factors and rates set out in the NFF guidance.

Government National Funding Formula Expectations

Every school must receive a minimum of £4,405 per pupil for primary schools, and £5,715 per pupil funding for secondary schools (KS3: £5,503, KS4: £6,033). This has been reflected in the APT.

Birmingham Methodologies

Apart from applying the rate specified in NFF Guidance, our forecast has increased the following factors in the APT:

- Split sites: increase by 1.9% in line with general NFF factor increase rate
- PFI top ups for PPP1 schools: increase by 10% need to check ONS rate in November 2022 as 2022/23 APT used ONS (Office for National Statistics) published RPI(X) rate in November 2021.
- NNDR business rates: 3% increase applied

Forecast of Schools Funding 2023/24 Based on August 2022 APT

We have applied NFF in the APT and Birmingham methodologies listed above based on pupil number estimates provided by Education Infrastructure (EDI). This shows a surplus of £4.45m.

We then applied ACA (Area Cost Adjustment) factor of 1.00338 as per NFF rate for Birmingham to most of other factors apart from the MPPL (minimum per pupil level) and the Premises factor. This shows a surplus of £1.86m, which will be used to fund expected increased costs for FSM and deprivation in the final DSG settlement.

The ACA is a multiplier applied to funding factors to reflect geographical variation in labour market costs (for teaching and non-teaching staff). Details are explained in the ACA technical notes via the link in the appendix.

The forecast shows that based on the estimated pupil numbers for October 2022, there is sufficient funding to apply NFF with MFG at 0.5% and ACA factors. The surplus of £1.86m is a small balance and is expected to reduce when DFE update the APT for October Census 2022 data.

We will provide updates at the next forum meeting.
