A number of quantitative and qualitative data sources have been used to inform the plan policies, including surveys, population data and data relating to land use.

Consultation analysis

The Jewellery Quarter Neighbourhood forum undertook several rounds of consultations during the production of the Neighbourhood Plan. The plan has been involved in extensive consultation with the area's communities over a long period of time with groundwork starting as far as 2011. To ensure residents of all ages (such as those with work commitments) would have the best chance of learning and contributing to the process of the neighbourhood plan, various opportunities were presented at different stages of plan production. The latest opportunity was the Regulation 14 consultation which took place between July 2020 and September 2020. During the course of plan production, events were hosted in a range of venues on different dates and times in order to be convenient for

all members of the community.

Involving the community in the development of these policies has been at the heart of the creation of the Jewellery Quarter Neighbourhood Plan, with the people who live and work in the area regularly engaged with to make sure their feedback was considered. The neighbourhood plan submitted included a consultation statement which shows how the neighbourhood plan was consulted and how they addressed the comments received.

The Regulation 14 consultation was accompanied by a range of online presentations and Q&A sessions. Nearly 200 individual comments were received from a range of parties and in general showed strong support for the Neighbourhood Plan and its policies. Comments were reviewed and processed by the Forum. A 'Reg 14 Comments Tracker' was produced and is appended to the submitted Consultation Statement. This summarised the comments received, and the action taken for each and every comment received. The Consultation Statement will be made available during the City Council's statutory consultation.

The City Council will undertake a statutory consultation on the Neighbourhood Plan that will be in accordance with the Council's adopted Statement of Community Involvement. All groups with protected characteristics will be involved and benefit from the implementation of the neighbourhood plan.
