

A Bold Safe Birchfield

Priority 1:	The effective monitoring and regulation of Supported Housing and Housing in Multiple Occupation to ensure that they meet planning and other legislation and existing tenants are properly supported, and that the numbers of properties do not exceed that which the wider community can accommodate without negative impacts on community cohesion and safety.
Why has this been chosen as a priority?	Residents' concern about the impact of unregulated accommodation on both tenants and the undermining of community cohesion and safety within the wider community.
Who will own this priority?	Birchfield Environment Strategy Group with HMO Action Group
Which organisations and groups do we need to engage and/or work with?	BCC – Housing, Planning, Adult Social Care and PRS teams, Midland Heart, Residents' groups, Faith groups, providers of Supported Housing and statutory agencies such as Police and Fire Services.

A Bold Green Birchfield

Priority 3:	Residents having pride in the area – its streets and open spaces – and working together with others to reduce fly tipping, improve street cleansing and raise environmental awareness including about waste and recycling. Improve inclusive access to quality green space within the Ward for example the new Crick Lane Playing Fields.
Why has this been chosen as a priority?	Residents' concern about the levels of fly tipping and poor quality of the environment including street cleaning, front gardens, open spaces, and the public realm in general. The need for residents to take greater pride and engagement in maintaining the quality of the environment. Birchfield is one of 13 areas of the city in most need of support to achieve inclusive access to good quality green spaces, according to the recent <u>City of Nature report</u>
