Beyond Birmingham 2022 – Celebrating Communities Fund Round 1 Summer 2023 Overview and Guidance

'Enabling a coordinated ward funding approach, to bolster local decision making and putting people at the heart of everything we do'

Overview

A new city-wide fund has been made available to <u>all 69 wards across Birmingham</u>, building on the success of the Celebrating Communities initiative, part of the Birmingham 2022 Community Fund. Grants of up to £10,000* are now available from Birmingham City Council (BCC) for community groups and organisations to run initiatives that meet the aims of the fund. Round 1 of the fund is open for applications from **1 June to 30 June 2023**.

Background

Birmingham 2022 Commonwealth Games enabled local communities to come together and celebrate the arrival of the Games, in their way, through the delivery of a range of activities across Birmingham. To mark one year from the Commonwealth Games, Beyond Birmingham 2022 – Celebrating Communities Fund Round 1 Summer 2023 will connect local communities to the Birmingham Commonwealth Games Legacy Festival taking place in the summer.

Aims of the fund

Grants of up to £10,000* are now available to run initiatives which deliver against one of three themes which are described as follows:

- Getting Active encouraging communities to get out and get active by participating in sports and
 recreational activities. The overriding aim should be to encourage residents, of all abilities and ages, to
 engage in physical activity and improve their health and wellbeing.
- Ready, Steady, Fun Connecting Communities delivering community projects such as improving
 communal space, and hosting community celebrations to develop active citizenship and reduce loneliness
 and social isolation.
- Celebrating Culture Supporting communities to showcase the culture of their local area developing
 community-led cultural events and initiatives that encourage intergenerational activities. Proposed
 schemes must harness the power of culture to bring people together, celebrate their identities, and the
 culture, heritage, and stories of their communities.

Who can apply

- Community groups and not-for-profit organisations can apply.
- Applicants should have a bank account, in the name of the group or organisation applying, or be able to
 identify a sponsor organisation to hold the funds of behalf of the group. If a group is not constituted, you
 can still apply for the funds, under the umbrella of another constituted group who will act as the fund
 holder for the grant (a sponsor).
- Individuals are not eligible to apply for this grant programme.
- Applications will be considered for up to £10,000.
- Only one application per organisation will be considered.
- Activity must take place in the Ward applied to.
- Multi-ward applications will not be considered in this grant round.
- Groups and organisations previously funded by NDSU who have not returned an evaluation will not be considered.

What we can support

We can make grants to most types of community activity or elements including core costs/essential running costs, revenue costs, small capital costs**, new projects or existing projects and one-off initiatives. ** Any small capital project must demonstrate a plan for their ongoing maintenance. The relevant council department will be consulted on any maintenance plans to provide assurance that the plan is robust.

How decisions are made

Applications will be reviewed against the criteria and a recommendation will be agreed at a Ward Forum meeting. Recommendations will be ratified by a Strategic Director to ensure the proposal is not already part of existing delivery plans, is financially affordable, legally achievable, and is compiled with Everyone's Battle, Everyone's Business principles and the Council's procurement procedure.

Birmingham Community Matters

Evaluation

All funded projects must complete a monitoring report to provide evidence in the form of photographs, social media posts/videos etc (compliant with GDPR), and commentary to explain how the project has engaged the community and worked towards the aims of the fund.

Application process

Beyond Birmingham 2022 – Celebrating Communities Fund Round 1 Summer 2023 will be open for applications between Thursday 1 June – 30 June 2023 at 5pm. Notifications of the outcome of each application and start dates for each project awarded funding will be flexible dependant of the dates of individual Ward Forum Meetings.
