**APPLICATION FOR PERMISSION TO HOLD A CHARITABLE OR FUND
RAISING CAR BOOT/MARKET WITHIN THE CITY OF BIRMINGHAM**

1. Commercial Car Boot Sales will not be permitted.
2. Car Boot Sales for charitable or fund raising purposes may be permitted at the discretion of the Council to any organisation or individual to hold a maximum of six Car Boot Sales during a calendar year.
3. A limit on venues of a maximum of six car boot sales during a calendar year, to be spaced one month apart.

Conditions of Operation

1. Prior permission of the Birmingham City Council Markets Division must be sought.
2. At least twenty-eight days notice of intent must be given.

NB: The holding of a car boot sale/market without having giving the requisite notice renders both the operator and occupier of the land liable to prosecution under Section 37 of the Miscellaneous Provisions Act 1982.

3. Licence fee of £54.60 to be received by Birmingham City Council Markets Division with each application/per day of event.
4. Each approved event/sale will be limited to no more than 50 cars (or stalls) and each and every vendor shall sell or display only articles surplus to their own domestic requirements, normally described as jumble or bric-a-brac and including books, records, small second-hand domestic furniture and equipment etc. Vendors selling new items and goods “brought-in” for re-sale, including bric-a-brac etc should not be permitted (unless previously agreed).
5. All income from charges to “car booters” must benefit the organisation identified in the application.
6. The event may be inspected by an officer of this Department and any car boots let above 50 will be charged at £1.00 per unit unless prior agreement has been granted. The letting of excess stalls could jeopardise the licencing of future events.
7. Any organisation or individual found to be contravening the above requirements may be prosecuted and/or banned from holding further sales.
