Homeless Centres is a type of temporary accommodation that is offered to homeless households. This is an accounting change - base budget no longer required for annuity payments on Magnolia House and Marford Walk as debt fully repaid which will be a saving £288K.
	Improvement works to these two homeless centres incurred borrowing charges to be repaid over 8 years up to 31st March 2024. Since this debt has now been repaid there will be no further charges.
