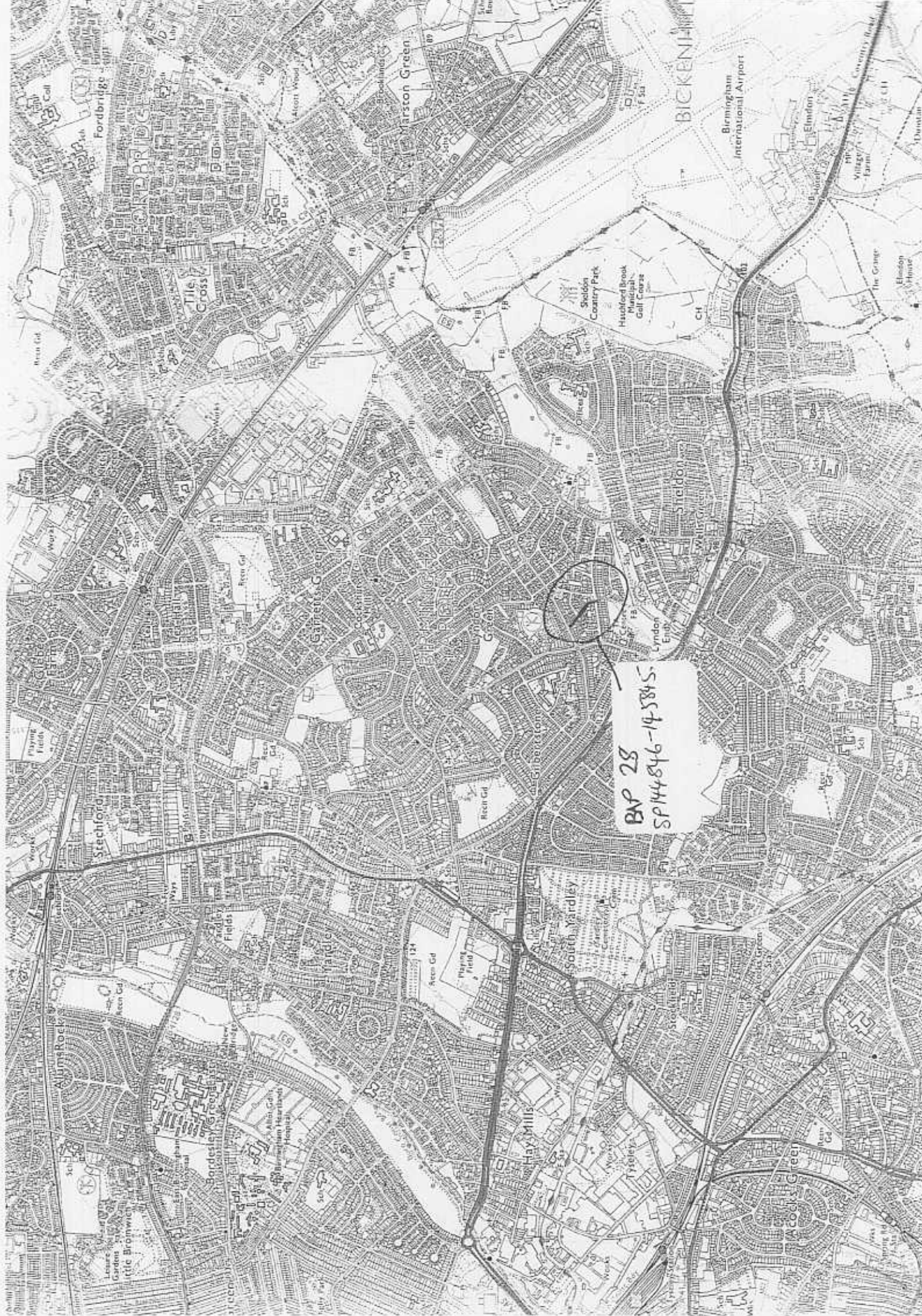

Statement of Evidence for Path Claim BAP 28

- 1 The path is first recorded on the 1887 edition of the Ordnance Survey 6 inch map, where it is labelled "FP".
- 2 The path is shown as a continuation of a path being diverted (RA Ref. BAP 29) in a Quarter Sessions Highways Order of 1936. (Held by the City Council in the Central Reference Library at QS/B/21/3 (box 15, item 24).)
- 3 The path has been retained through the housing development, including Leys Wood Croft, and is shown as such on all recent and modern Ordnance Survey maps, including the 1/10,000 and 1/25,000 scales.
- 4 The path is recorded on the (undated) City Council map of public rights of way.
- 5 The path has a well maintained tarmac surface, with no barriers or other obstructions.
- 6 It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the Definitive Map.
