# **About your EIA**

Subject of EIA:	Stopping the commercial waste service into Tysley incinerator
Description:	The purpose of the policy is to stop local traders tipping into Tysley incinerator at a reduced rate and therefore to remove the service completely The policy will be achieved by removing the ability for traders to tip into the incinerator. The residents of Birmingham City Council will benefit as their council tax will no longer be used to fund the disposal of commercial waste. The proposed revision is that local traders will no longer be able to tip into Tysley incinerator at a reduced rate It is different to current practice as currently traders are able to tip into Tysley incinerator. As per previous discussions the following information is being provided: A concern was raised that this policy would lead to an increase in fly tipping. In response to this challenge the following can be confirmed: 1) This policy only affects traders the risk is therefore minimal as the waste disposal industry is heavily regulated and traders are monitored to ensure they have Waste Carriers Licences, registered with disposal outlets and have the approriate documentation. It is therefore believed that the risk is minimal. 2) As part of the consultation process all the traders have been offered access to Birmingham City Council's skip service as an alternative means of disposal. 3) The majority of the traders are registered outside of Birmingham and therefore it was believed the risk of flytipping was not outweighed by the burden being placed on the tax payer in the City to fund the disposal of their trade waste. Service Implementation Date - November 2024 Consultation Undertaken - Traders were made aware of the decision to withdraw the service in October 2024, it is acknowledged that the consultation could have been more extensive. However it should be noted that when the traders approached the Council they were engaged with in a postive and proactive manner.
