| Description:            | This is a series of savings to the General Fund through the use of the Public Health Ring Fenced Grant (PHRFG). The Public Health Ring Fenced Grant . The Grant is provided to the local authority by Department of Health and Social Care to deliver its statutory, prescribed and recommended functions. The funding is also used to fund Birmingham City Council to deliver its public health outputs and outcomes where they are assessed to be eligible. The savings are focussed at underspends, use of alternative unanticipated grants and making savings to PHRFG allocated to some projects in Birmingham City Council and reallocating that funding to alternative eligible projects in Birmingham City Council . Of the £1.44m the only reduction is £150k to City Ops which was aimed at transforming Wellbeing Services . Funding which delivers services to citizens have been safeguarded. The overall impact is additional investment of £1.44m to the Birmingham Children's Trust. Public Health Division are therefore not making savings. City Ops is making the saving of £150k. |
