Data sources Details:	<p>Concession tenders will cover several parks across the city. Visitors to Birmingham's parks can come from anywhere in the city and even further afield to the parks in question. The demographics data for Birmingham indicates there are 1.44 million people living within the city of which 20.9% are aged 0-15 years old and 13.1% are aged 65 and over. Birmingham is a diverse city with a population consisting of 48.6% white, 31% Asian/Asian British, 11% Black/African/Caribbean/Black British, 4.8% Mixed/Multiple ethnic and 4.5% Other ethnic groups. Feedback from consultation surveys indicate visitors would like to see more attractions/activities to participate in when they visit Birmingham's parks, and so the aim of this review of concessions in parks is to enhance the visitor experience to parks whilst generating income for the Council. Work is progressing on 7 concession tenders to go to market ASAP in 2025 i.e. High ropes attraction in Sutton Park, open air cinema in selected parks, Handsworth Park café/boathouse, Lickey Hills Visitor Centre café, Woodgate Valley Riding Centre, Victoria Common former Sons of Rest building and Handsworth Park former Sons of Rest building. The concession tenders will be open market tenders i.e. we will ask the market to determine what their offer will be e.g. commercial offering, pricing, fee to BCC, menu and food type (where applicable) etc. So, whilst no information is available in advance regarding the food offering/menu choices, the tender will set out the requirement to offer healthy food choices, as well as display allergen and a full price list of the food on offer when trading. The tender process will ask potential providers to detail how they will cater for individuals with different needs/requirements alongside accessibility measures. In addition, there are additional concession opportunities in the pipeline at various stages of development i.e. Woodgate Valley Visitor Centre, Sea Ranger buildings in Sutton Park, coffee shop development opportunity in Sutton Park as well as the re-tendering of the mini-golf and leisure boat attractions at Sutton Park. Discussions with Parks colleagues i.e. District Park Managers and Park Rangers, has also been used to populate this EIA.</p>
