

CARE FEES 2025/2026

The following fees will apply to all new and existing packages of care with contracted providers under the contracts listed in the table below, from Monday 7 April 2025 (or from date of contract award, whichever is the latter).

N.B. this does not apply to the Quick Discharge Service contract for which increases will only apply to new packages starting from 7 April 2025 onwards. Existing packages commencing prior to 7 April 2025 will remain at the 2024/25 rates.

For the avoidance of doubt, existing packages of care (commissioned under 2018 flexible contracting arrangements for care home, supported living or home support sensory loss services) will not be uplifted to the fees set out below until the care provider has been awarded a 2023 care home, supported living or home support sensory loss contract. Existing packages of care (commissioned under the 2019 Framework for the Provision of Home Support for Children, Young People with Disabilities and Home Support for Adults) delivered by providers which have not been awarded a Flexible Contracting Arrangement for the Provision of Home Support for Children and Young People with Disabilities and Homes Support for Adults 2024 will not be uplifted to the fees set out below:

Younger Adult Care Homes 2023 contract holders

- The following fees will apply to all new and existing younger adult packages of care with contracted providers (2023 care home contract holders only), from Monday 7 April 2025 (or from date of contract award, whichever is the latter):
- There is a Guide Price in place which operates under 6 price bands dependent on a care hours assessment of the citizen's unmet eligible care and support needs.
- For existing packages above or at different rates to the 6-band price structure below fees will be increased by 7.37%
- You may be required to submit an Open Book template as part of this process.

Notes:

1. **Placements outside of Birmingham** – For Out of Area care home placements commissioned at the host local authority fee - the Council will pay the associated increase once this is determined by the host local authority and once the provider has been awarded the Council's 2023 Flexible Contracting Arrangement only. For out of area placements commissioned at the Birmingham standard residential fee or Birmingham standard nursing fee then the fees will increase to £728 and £831 respectively, again once the provider has been awarded the Council's 2023 Flexible Contracting Arrangement only.
2. **Care Home Block Contracts (Interim and EAB beds)** – Fees will increase from 7 April 2025 by 6.54% and excluding FNC.
3. **Extra Care Sheltered Housing** – Fees as follows from 7 April 2025:
 - a. Spot purchased Extra Care hours will increase to £21.23/hour (7.73%)
 - b. Block arrangement Extra Care hours will remain at £16.00/hour
4. **Externally Commissioned Day Opportunities** – Fees will increase from 7 April 2025 by 7.37%.
5. **Direct Payments** – All existing Direct Payments as at 7 April 2025 will increase as follows with any new Direct Payments entered into on or after 7 April 2025 being paid as follows:
 - a. Use of a personal assistant will increase by 6.18% to £14.06/hour
 - b. Use of a CQC Registered care provider will increase by 6.36% to £23.35/hour for home support; by 8.00% to £21.42/hour for supported living; and 7.73% to £21.23 for Extra Care Sheltered Housing.
6. **Non-Contracted Providers** - These fees or associated increases do not apply to providers not commissioned under the above-named arrangements and/or contracts.
7. **For providers who do not apply for/not awarded a 2023 contract (care homes, supported living or home support sensory loss)** – please note there will be no increase in your fees until such time as you are awarded a 2023 contract.
