

Statement of Evidence for Path Claim BAP 95

- The path is first recorded in 1851 when a short section, parallel to the river, was created by the Sutton Coldfield Inclosure Award, as path No. LV. (The Award I held by Warwickshire County Record Office at OS75/111/1.)
- The route is shown on the deposited plans for the Birmingham Waterworks 1869, in various parcels. The Book of Reference lists these as:- Curdworth No.3: meadow, footway and stream; No.4: meadow, occupation road, footway and stream; and Sutton Coldfield Nos. 2, 3, 4, 5, and 6: meadow, occupation road, footway and stream. In all cases the owners included the Surveyor of Highways. (Held by WCRO at QS111/297.)
- The path is shown on the first edition of the Ordnance Survey six inch map of 1887.
- The whole route is shown on the deposited plans for the Birmingham Tame and Rea District Drainage Board Works 1896, for the acquisition of the land. It is labelled on the plan as "Footpath to be stopped up", while the Book of Reference includes "footpath" in the description of each parcel (parcels 125, 124, 123, 122, 121, 202, 203, 117, 204, 210, 211, 201 and 212). In each case the owners listed included the Surveyor for the relevant parish. (Held by WCRO at QS111/492.)
- 5 No Order has been, however, for the closure or diversion of the path.
- The replacement path was diverted by the "Birmingham City Council (Minworth Sewage Disposal Works) Public Path Diversion Order 1996!, which specified a width of 2m for the new path. The Order was made on 26 April 1996, was confirmed by the Secretary of State on 26 February 1998, and became operative on 9 April 1998.
- The east end of the path, which lies in Warwickshire, is recorded on the Definitive Map for that county with the reference number M453, in Curdworth parish.
- A consultation on a further proposed diversion, which listed the path as No.2537, was carried out in May 2007, but no Order was made.
- 9 The path is recorded on the (undated) City Council map of public rights of way.
- It is considered, therefore, that it is reasonable to allege that the route subsists as a public footpath and should be recorded as such on the Definitive Map.
