

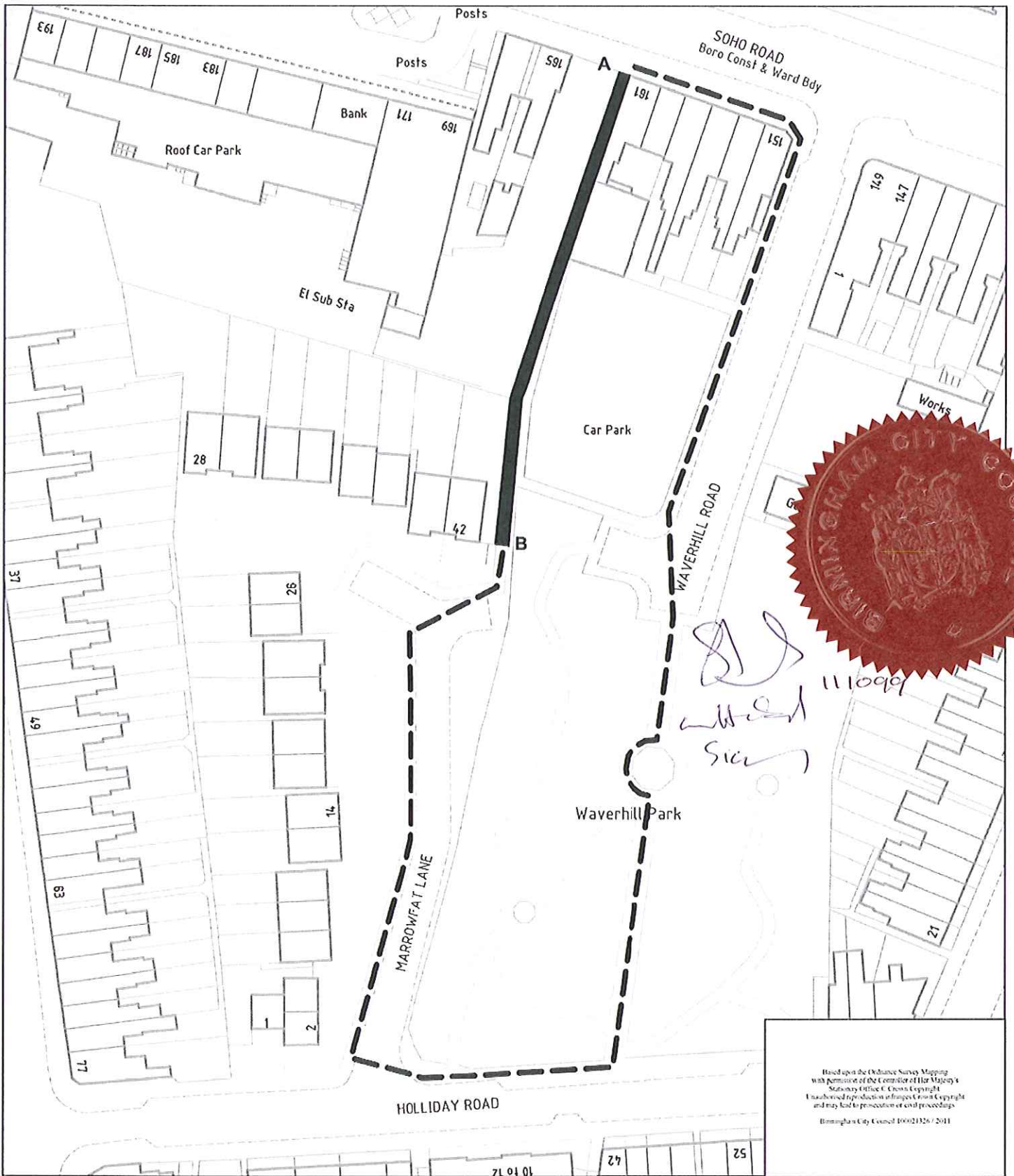
SECTION 129A OF THE HIGHWAYS ACT 1980 (AS AMENDED)

**BIRMINGHAM CITY COUNCIL (SOHO ROAD/MARROWFAT LANE, LOZELLS AND
EAST HANDSWORTH) GATING ORDER 2012**

This Order is made by Birmingham City Council ("the Council") in exercise of its powers under section 129A of the Highways Act 1980 (as amended) because the Council is satisfied that the premises adjoining or adjacent to the public right of way described in the schedule below are affected by anti-social behaviour and the existence of the public right of way described in the schedule below is facilitating the persistent commission of anti-social behaviour and it is in all the circumstances expedient to make the Order for the purpose of reducing anti-social behaviour.

By this Order

1. The public right of way over the highway described in the schedule below and as shown with a black solid line on the Order Plan shall be restricted at all times by the erection of gates at points A and B as shown on the Order Plan.
2. The alternative route for pedestrians will be the footways that run along Soho Road, Waverhill Road, the public footpath through Waverhill Park and the footways that run along Holliday Road, and Marrowfat Lane as shown with a black dashed line on the Order Plan.
3. Police, Fire Service or Ambulance personnel, statutory undertakers with equipment situated over, along or in the public right of way, Council officers and other personnel authorised in writing by the Council for the purposes of carrying out works or repairs or maintenance to the public right of way or adjoining premises shall be exempt from the provisions of this Order.
4. Any person whose property adjoins the public right of way to be gated under the authority of this Order shall be entitled to be provided with a key on request.
5. The person responsible for maintaining the gates is the Council via the Perry Barr Constituency Engineer, Perry Barr Constituency, Tamebridge House, Aldridge Road, Perry Barr, Birmingham B42 2TZ. Telephone 0121 303 7619.
6. "The Order Plan" means map number DS.TD.HIS.ROW.MM.FPF1175 (annexed hereto).
7. This Order shall take effect on the date of execution.
