1. Morning deployment from depots:

Atlas and supporting depots: As of 04:30am 15 vehicles have been deployed from Atlas and alternative depots; 16 Coventry crews deployed. As of 08:30 am 19 vehicles still to be deployed. There is a protester blockade of 8 activists on Redfern Road. The activists are pigeon walking in front of the vehicles stopping them from deploying. Separately there are approx. 30/40 Unite protesters in the designated fenced off areas. Police are yet to arrive on site.

Smithfield: 30 vehicles have been deployed from Smithfield and 2 Coventry crews deployed. There is a picket at Smithfield depot today on Sherlock Street with approx. 40/50 protesters present. All vehicles deployed safely by 6:30am.

Perry Barr: As of 08:30, 1 BCC vehicle has been deployed; 7 Coventry crews deployed. 20 BCC vehicles are still to be deployed. There is a protester blockade of 8 activists on Holeford Drive at the entrance to the depot. The activists are pigeon walking in front of the vehicles stopping them from deploying. Separately there are approx. 30/40 Unite protesters in the designated fenced off areas. Police are in attendance.

Total number of waste collection vehicles deployed today so far: 71, including 46 BCC vehicles and 25 for Coventry. As of 08:30am there are 39 BCC vehicles not deployed.

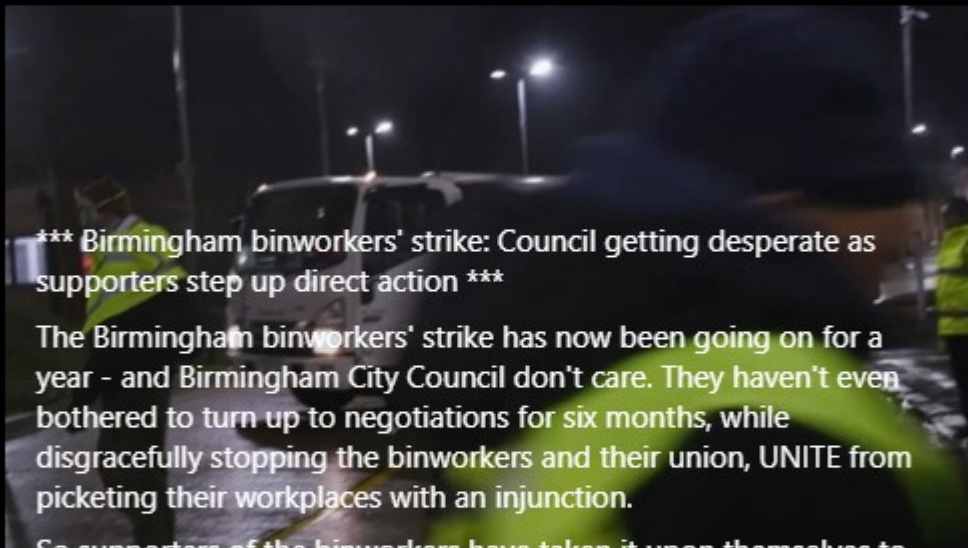

*** Birmingham binworkers' strike: Council getting desperate as supporters step up direct action ***

The Birmingham binworkers' strike has now been going on for a year - and Birmingham City Council don't care. They haven't even bothered to turn up to negotiations for six months, while disgracefully stopping the binworkers and their union, UNITE from picketing their workplaces with an injunction.

So supporters of the binworkers have taken it upon themselves to take direct action and shut down depots instead - and these actions are increasing week by week, leaving the service in complete chaos and the council increasingly desperate as their popularity nosedives.

This video shows how you can shut down a depot, with footage from one of the solidarity pickets on January 12. So now it's over to you. UNITE is barred from organising these actions, but the rest of us can; so why not turn up at a depot with your mates one morning and do a slow walk yourself?

It would be massively appreciated by workers who still have the threat of an 8K a year pay cut hanging over their heads - and it could really help in forcing the council to resolve this dispute once and for all - for the workers, and for the people of Birmingham. See less

Atlas and supporting depots: 36 BCC vehicle have been deployed from Atlas and alternative depots; 14 Coventry crews deployed. There is a picket on Kings Road with approx. 30/40 protesters. All vehicles deployed safely by 07:10am.

Smithfield: 30 BCC vehicle have been deployed. There is a picket outside the depot with approx. 15/20 protesters. All vehicles deployed safely by 06:30am.

Perry Barr: 3 BCC vehicle have been deployed; 7 Coventry crews deployed. There is a picket at the depot with activists' pigeon walking in front of the vehicles stopping them from deploying. This has also affected 4 Street Cleansing vehicles from deploying. There are approx. 30/40 protesters. Police have been called and are on site however they will not intervene until three hours have passed from the time the call was made to them which was approx. 06.10am.

Total number of waste collection vehicles deployed today so far: 90, including 69 BCC vehicles and 21 for Coventry. As of 08:30am, there are still 18 Refuse vehicles and 4 Street Cleansing vehicles to be deployed from Perry Barr depot.

1. Morning deployment from depots:

Atlas and supporting depots: 36 BCC vehicle have been deployed from Atlas and alternative depots; 14 Coventry crews deployed. There is a picket at the depot this morning on Redfern Road with approx. 20/30 protesters. All vehicles deployed safely by 06:50am.

Smithfield: 31 BCC vehicle have been deployed. There is a picket outside the depot with approx. 20/30 protesters. There is no picket or protesters outside Lifford depot. All vehicles deployed safely by 06:40am.

Perry Barr: 22 BCC vehicles have been deployed from the depot:6 Coventry crews deployed. There is no picket at the depot this morning however there are approx. 30/40 protesters. All vehicles deployed safely by 06:40am.

1. Morning deployment from depots:

Atlas and supporting depots: As of 08:30am, 14 BCC vehicle have been deployed from Atlas and alternative depots at 04:30am; 18 Coventry crews deployed. There are currently activists' pigeon walking in front of the deployment gates stopping vehicles from deploying. There is a picket at the depot this morning on Redfern Road with approx. 30/40 protesters. 18 vehicles still to be deployed.

Smithfield: 30 BCC vehicle have been deployed. There is no picket or protesters outside the depot. There is no picket or protesters outside Lifford depot. All vehicles deployed safely by 06:30am.

Perry Barr: As of 08:30am, 0 BCC vehicles have been deployed from the depot: 8 Coventry crews deployed. There are currently activists' pigeon walking in front of the deployment gates stopping vehicles from deploying. There is no picket at the depot this morning however there are approx. 20/30 protesters who left at around 08:15am. 22 vehicles still to be deployed.

Overview of conversation: *The activist confirmed he would authorise the release of the clinical waste vehicles only*

3. Interaction with Police

Did you speak to the police: **Yes**

Time: **05:15**

Who was spoken to: *Justin Hilyer spoke to Sargent. Justin provided an overview of how the previous weeks protests had been managed. Michael Chipman spoke to a Constable who advised he was not prepared to take any details from the activists and that there was an 'agreement in place with management that vehicles would be released every 5 minutes'*

Did the police refuse to move the activists on? **Yes** – *The police advised that the activists had informed them that they have a 'deal' with management and will allow for vehicles to be deployed every 5 minutes. For the avoidance of doubt no such deal has been agreed.*

C. Smiles contacted the Force Decision Makers and advised that this information was incorrect. Force Decision Makers advised they will 'pass this onto the officers on the ground'

Can the police identify the activists? *Police were not prepared to ascertain this information from the activists*
