1. **Job Purpose**

- 1.1 To work under the supervision of the cook in the preparation, cooking and serving of nutritional well balanced meals for children and staff
- 1.2 To comply with the regulations for Food Hygiene and Health and Safety

- 2.1 To transport the necessary ingredients for the days menu from the main kitchen to the House kitchen by trolley
- 2.2 To assist the cook as required with the cooking and the service of lunch
- 2.3 To prepare all fresh fruit, vegetables and salads
- 2.4 To undertake cleaning and washing up duties within the kitchen as outlines in the cleaning schedule provided by the Domestic Bursar
- 2.5 To be responsible for the cleaning and replenishing of the dining room sideboards and cupboards
- 2.6 To adhere to the food safety system which is in place ensuring that work is carried out in accordance with the legislation relating to Food Hygiene and Health and Safety
- 2.7 To maintain, at all times, a good standard of dress and appearance using the uniform provided by the School
