1. **Job Purpose**
  - 1.1 To work under the direction of the Domestic Bursar in order to prepare, cook and serve nutritional well balanced meals for children and staff
  - 1.2 To supervise the assistant cook and maintain a smooth running and well organised Kitchen
  - 1.3 To comply with the regulations for Food Hygiene and Health and Safety
2. **Key Responsibilities**
  - 2.1 To ensure that the necessary ingredients provided are transported from the main kitchen to the House kitchen by trolley
  - 2.2 To follow the set weekly menu provided by the Domestic Bursar
  - 2.3 To prepare, cook and serve food for breakfast, lunch and tea. This includes culturally acceptable meals and special dietary requirements as notified by the Domestic Bursar
  - 2.4 To undertake cleaning and washing up duties within the kitchen as outlines in the cleaning schedule provided by the Domestic Bursar
  - 2.5 To adhere to the food safety system which is in place ensuring that work is carried out in accordance with the legislation relating to Food Hygiene and Health and Safety
  - 2.6 To maintain, at all times, a good standard of dress and appearance using the uniform provided by the School
  - 2.7 To ensure all tasks are carried out with due regard to Health and Safety
  - 2.8 To undertake appropriate professional development including adhering to the principle of performance management.
