1. I, Glenn Marriott for Expert Investigations Ltd of [REDACTED] will state:
2. I am a Process Server acting under the direction of DLA Piper UK LLP and this statement has been prepared based on evidence collated by myself.
3. At 1421hrs on Thursday 5th February 2026 I received an email from Lotte Frorup DLA Piper containing Notice of Injunction Application Hearing Date. I printed off 2 copies of the Notice and sealed them inside plastic wallets. I also received Notice of Birmingham Court Order. I printed off 2 copies of the Notice and sealed them inside plastic wallets.
4. I also printed off 200 x A5 sized Notice of Injunction Application Hearing Date, to hand out to persons present at the locations, protesting.
5. At 0600hrs Friday 6th February 2026 I attended Lifford Lane Depot, Ebury Road, Kings Norton, Birmingham, B30 3JJ.
6. At the main gated entrance to the premises, I affixed both Notices of Injunction Application Hearing Date and Notices of Birmingham Court Order securely to the gates using cable ties, in locations where they would be clearly visible. I removed the Notices which I had attached on 4th February 2026.
7. That a copy of the affixed Notices of Injunction Application and Hearing date and Notices of Birmingham Court Order are attached with this statement as Exhibit GM/3
8. That a copy of the affixed Notices of Birmingham Court Order are attached with this statement as Exhibit GM/4
9. A series of photographs of the affixed Notices at the location were taken and are attached as Exhibit GM/5.
10. There were no protestors in attendance at the location.
11. I then attended Smithfield Depot, Sherlock Street, Birmingham, B5 6HX in order to hand out leaflets to protestors, however there were no protestors present.


