


1. I, Glenn Marriott for Expert Investigations Ltd of [REDACTED] will state:
2. I am a Process Server acting under the direction of DLA Piper UK LLP and this statement has been prepared based on evidence collated by myself.
3. At 1421hrs on Thursday 5th February 2026 I received an email from Lotte Frorup, DLA Piper containing an A5 sized Notice of Injunction Application Hearing Date. I printed off 200 of these Notices for distribution to protestors at the following Depots.
4. At 0600hrs Tuesday 10th February 2026 I attended Perry Barr Depot, Holford Drive, Birmingham, B42 6HX. There were no protestors present at the location. I spoke to a member of staff who stated that he hadn't seen any protestors for a few days.
5. At 0630hrs Tuesday 10th February, I attended Smithfield Depot, Sherlock Street, Birmingham, B5 6HX in order to hand out leaflets to protestors. There were 6 protestors present at the location; all were wearing face coverings. I attempted to hand out leaflets to all 6 persons present, however they all declined to take the leaflet. A female was present and kept shouting 'they are injunctions, you don't have to take them'
6. At 0650hrs same day, I attended Atlas Depot, 70-172, Kings Road, Tysley, B11 2AS in order to hand out leaflets to protestors, however there were no protestors present.
7. At 0713hrs same day, I attended Lifford Lane Depot, Ebury Road, Kings Norton, Birmingham, B30 3JJ, however there were no protestors present.
8. Photographs were taken at the 4 x Depots attended and are attached as Exhibit GM/7
9. I believe that the facts stated in this witness statement are true. I understand that proceedings for contempt of court may be brought against anyone that
