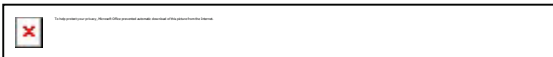
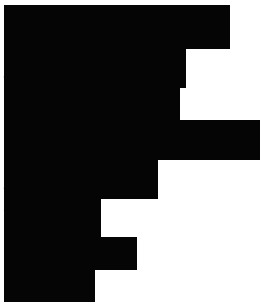
Hi Deborah,
